#### FINANCIAL ARRANGEMENTS




ARTICLE-VII

For purposes of this MoU, "confidential information" means any information whether prior to or here in after disclosed by a party (the Disclosing party) to the other party (the receiving party) of this MoU involving technical, business, marketing, policy, know-how, planning, project management and other information, data and /or solutions in any form, including but not limited to any information which is designated in writing to be confidential or by its nature intended to be for the knowledge of the receiving party or if orally given, is given in the circumstances of confidence. Both parties agree that the provisions of this clause shall continue to be binding between the parties notwithstanding the termination of this MoU.

## **5. SETTLEMENT OF DISPUTES**

Any difference or dispute between the parties concerning the interpretation and/or implementation and/or application of any of the provisions of this MoU shall first be settled amicably through mutual consultation and/or negotiations between the parties in the event of non-resolution, references shall be made to a mediator jointly appointed by the parties who shall mediate the dispute o difference in question.

## **6. NON CONTRACTUAL NATURE OF RELATIONSHIP**

Save for clause 4, the parties agree that this MoU represents the mutual understanding of the Parties and is not intended nor shall be deemed to be a contract and shall not give rise to any rights and liabilities under a contract. Nothing contained herein shall be construed so as to constitute a joint venture partnership or formal business organization of any kind between the parties or so to constitute either party as the agent of the other. The parties acknowledge that this MoU does not in any way give rise to any right or permission to use or to be associated with each party's intellectual property.

## **7. REVISION, VARIATION AND AMENDMENT**

Either party may request in writing a revision, variation or amendment of this MoU. Any such revision variation or amendment agreed to by the parties shall be in writing and shall form part of this MoU. Such revision, variation or amendment shall come into force on such data as may be determined by the parties. Any revision, variation or amendment shall not prejudice the implementation of any project, activity of co-operation arising from or based on this MoU before of up to the date of such revision, variation or amendment.

## **8. SUPERVENING EVENTS**

8.1 Each party reserves the right for reasons of national security, national interests, public order or public health to suspend temporally, either in whole in part, the implementation of this MoU which suspension shall take effect immediately after notification has been given to the other party.

8.2 Notwithstanding sub-clause 8.1, should any other event occur which hinders or restricts the implementation of this MoU, the parties shall use their best endeavor to agree upon such action, as may be necessary and equitable, to remove the cause of such event.



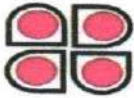

- f) Any other areas and / or forms of co-operations mutually agreed upon by the parties for managing e-waste.

## **ARTICLE – III**

### **FINANCIAL ARRANGEMENTS**

The financial arrangements to cover expenses for the e-waste disposal within the framework of this memorandum of Understanding shall be mutually agreed upon by both the parties on a case –by case basis subject to availability of funds

## **ARTICLE – IV**

### **PROTECTION OF INTELECTURAL PROPERTY RIGHTS**

- a) The protection of intellectual property rights shall be enforced in conformity with the national laws, rules and regulations.
- b) Not with standing anything in paragraph (a) above the intellectual property right in respect of any technological development and any product and services development, carried out
- c) Jointly by the parties or research result obtained through the joint activity effort by the parties, shall be jointly owned by the parties in accordance with the terms to be mutually agreed upon



**ARTICLE – V**  
**CONFIDENTIALITY**

Each party undertake to observed the confidentiality and secrecy of documents information and other data received from or supplied to the other party during the period of the implementation of this memorandum of understanding or any other agreements made pursuant to this memorandum of Understanding.

b) Both parties agree that the provisions of this article shall continue to be binding between the parties notwithstanding the termination of this Memorandum of Understanding

**ARTICLE –V I**  
**REVISION, MODIFICATION AND AMENDMENT**

- a) Either party may request in writing a revision, modification or amendment or all or any part of this memorandum of Understanding
- b) Any revision, modification or amendment agreed to by the parties shall be reduced into writing and shall form part of this memorandum of Understanding
- c) Such revision, modification or amendment shall come into force on such date as may be determined by the parties and
- d) Andy revision, modification or amendment shall not prejudice the rights and obligations arising from or based on this memorandum of Understanding prior or up to the date of such revision, modification or amendment

**ARTICLE –VI I**  
**SETTLEMENT OF DISPUTES**

Any difference or disputes between the parties concerning the interpretation and / or implementation and / or application of any of the provision of this memorandum of Understanding shall be settled amicably through mutual consultation and or negotiation between both the parties and if the same is not resolved through

Negotiation or by adopting amicable measures in that case the matter settled through Arbitration and the arbitrator will be appointed with the mutual consent of both the parties without reference to any tribunal or court at Chandrapur.

## ARTICLE – VIII

### ENTRY INNTO FORCE, DURATION AND TERMINATION

- a) This memorandum of Understanding shall come into force on the date of sighing and shall remain in force for a period of five(5) years. Willingness to extend the MoU for a specified period may be initiated six months in advance and further agreed by both the parties
- b) Notwithstanding anything in this Article, either party may terminate this Memorandum of Understanding by notifying the other party of its intention to terminate this Memorandum of Understanding by a notice in writing at least three (3) months prior to its intention to do so and
- c) The termination of this memorandum of Understanding shall not affect the implementation of on-gong activities and or programmers which have been agreed upon before the date of the termination of this memorandum of Understanding
